HOUSE POLICIES

The following House Policies are to be observed by all guests. These House Policies have been set forth by the House to maintain a clean, safe and healthy environment with mutual respect for all concerned. Any infractions of these house policies may result in a written write up called a "strike," with the consequences to be determined by staff and no overnight pass for seven days. If any guest receives three strikes within a thirty-day period, it may result in further restrictions or termination of the guest agreement with the House.

- **Noise:** No loud music or television. Keep the noise down in the patio area after 8PM. be respectful and courteous to our neighbors and others.
- **Visitors:** Are to be entertained in community areas ONLY. They are not allowed in bedrooms for any reason, unless prior permission by management has been granted. You are responsible for your guests' behavior, and they must abide by the same rules and policies as set forth in your gest agreement.
- **No Smoking or Vaping:** Inside any of the units or the sign out board walkway, Smoking or Vaping is allowed ONLY at the designated backyard table.
- **Each Guest:** Is responsible for washing their own dishes immediately after each use, drying them and putting them away. Each guest must keep his sleeping and living area clean at all times of the day and night. No personal items are to be left in the community areas.
- **Out of Bounds:** Guests may not enter another guest's room or unit without their permission.
- **Job Assignments:** Guest property and house chore assignments must be completed on designated days.
- **Curfews:** Sunday-Thursday: 10 PM/Friday-Saturday: 12 AM. No leaving after curfew, unless approved by staff.
- **Sleeping:** Monday-Friday guests must be awake and out of bed by 9 AM. Guests may not sleep in community areas or lay on couches. As a courtesy to other guests, televisions and radios may not be left on in guest rooms while sleeping.
- **House Activities:** Guests agree to attend and participate in the house activities including the house business and community meetings, unless pre-approved by staff.
- **Meeting Attendance:** Meetings are to be attended daily unless pre-approved by staff. Guests may be required to have meeting attendance slips signed and turned in weekly at house business meetings. You are required to have at least 3 to 5 meetings signed on your meeting cards.
- **Dress Code:** All guests must be properly dressed in community areas. Guests must wear pants or shorts and shirts in all community areas.

- **Pornography**: No guest is allowed to have pornographic material of any kind on the premises, including on computers and through computer streaming.
- **Gossip/inappropriate Speech**: Gossip, character assassination of others, criticism, drug talk, drug glorifying and speaking ill of others will not be tolerated. This includes disrespectful or aggressive speech behavior.
- **Overnight Passes**: Guests having less than 30 days of continuous sobriety will not be allowed an overnight pass. Guests having 31 or more days of continuous sobriety may apply for two overnight passes a week for any day. Guests applying for a pass must have at least 3 days on the premises and fill out an overnight pass request to be submitted 24 hours in advance. Overnight passes require written approval from the staff. Guests must have their chores covered during their absence. If a guest has received a write up within the previous seven days, no pass will be granted.
- **Borrowing Money**: Borrowing from or loaning money to another guest is PROHIBITED.
- **Automobiles**: Loaning your auto to another guest is PROHIBITED: You must have current auto insurance in place to be allowed to use your car while a guest is at the House.
- **UA Testing**: All guests will be required to submit to random drug and/or alcohol testing. UA tests must be supervised and verified by the house manager via visual confirmation. If refused, the guest must submit to an onsite oral test. Guests must submit to a drug test within 1 hour of the test request and may not leave the property until the test is given. Failure to comply with testing procedure will constitute a dirty test.
- **Life Coaching/Recovery Coaching**: All guests are required to participate in the group life coaching program. The cost of group life coaching is included in the monthly guest fee.
